## **Monthly Report**

In March 2020, overall there is a clearly decline observed due to pandemic COVID-19 in healthcare services that are being reported in DHIS. Total OPD visits in March 2020 were 13.7M and in February 2020, OPD visits were 14.3 M. Hence, the decline percentage is 5% in OPD. Similarly, it is mentioned in this report that there's a decrease in Family planning visits, ANC-I visits and Deliveries conducted in health facilities, because of COVID-19 and OPD of THOS were closed by the 23<sup>rd</sup> of March.




The graph shows the Month wise comparison of total OPD visits (new & follow up cases). The number of OPD visits has increased year to year, but in March 2020, there is a slight decline of 6% as compared to previous year for the month of March. In March 2020, total 13.7 M patients were reported in DHIS.


#### **Percentage of OPD in SHC & PHC**

The pie chart shows a percentage of OPD visits in SHC (Secondary Health Care) and PHC (Primary Health Care).

As, Secondary Health Care includes all THOS, DHQ, THQ and Civil hospitals and Primary Health care includes all BHU's , RHC, Dispensaries and MCH centers. Percentage of OPD visits (New cases + Follow up cases) in SHC were 42% and percentage of PHC were 58%.



#### **Priority Diseases**





#### **Family Planning Visits & Commodities**




#### **Family Planing Vists**

For the Month of March (2020) Total number of Family Planning Visits are **158K** (157,834). The following table shows the number utilization of commodities corresponding to these visits:



#### **ANC-I Visits**



This numbers is calculated from the expected pregnancies during the year (3.4% of total Population). The number has improved from year to year (Mrach2016 to March 2018) but there is a decline in March 2019 and March 2020 because of rectification of revisits data into ANC-1. Directions to Health facilities were given regarding ANC-1 & ANC revisits. ANC-1 visits in the month of March were 274k (274,464)

Figure shows а percentage of deliveries conducted (Normal vaginal deliveries, Vacuum/forceps, Cesarean Sections) in the March for recent three years. The highest percentage was observed in the year 2018 i.e. 40%. There is a slight decline of 3% as compared to March 2019. In 2020 (March) there is a lowest percentage observed i.e. 31%. There is decline because of counter verification of IRMNCH & Roadmap. The number of deliveries conducted in March 2020 were 87,751.
